**ORDER GRANTING THE THIRTY-SECOND OMNIBUS OBJECTION  
OF PLAN ADMINISTRATOR SEEKING TO DISALLOW  
CERTAIN NO LIABILITY CLAIMS**

This matter coming before the Court on the *Thirty-Second Omnibus Objection of Plan Administrator Seeking to Disallow Certain No Liability Claims* (the “**Objection**”);<sup>1</sup> and the Court having reviewed the Objection and the Rinaldi Declaration; and the Court finding that (i) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (ii) venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409, (iii) this is a core proceeding pursuant to 28 U.S.C. § 157(b), and (iv) notice of the Objection was adequate and in compliance with the Case Management Order, the Bankruptcy Code, the Bankruptcy Rules, and the Local Bankruptcy Rules; and the Court having found and determined that the relief sought in the Objection is in the best interests of the Debtors’ estates and their creditors and other parties in interest; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor; it is

**ORDERED** that the relief requested in the Objection is granted; and it is further

**ORDERED** that pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rule 3007, and the Second Amended and Restated Plan, the No Liability Claims listed on Schedule 1 attached hereto are hereby disallowed with prejudice and expunged in their entirety from the Claims Register; and it is further

**ORDERED** that if the relief requested in the Objection is not granted herein as to any particular No Liability Claim, the Plan Administrator may object to such No Liability Claim in the future on any basis; and it is further

**ORDERED** that GCG, Inc., the Plan Administrator's notice and claims agent, is authorized to cause the Claims Register to be amended to reflect the terms of this Order; and it is further

**ORDERED** that the Plan Administrator is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection; and it is further

**ORDERED** that the terms and conditions of this Order shall be immediately effective and enforceable upon entry of the Order; and it is further

**ORDERED** that this Court shall retain jurisdiction with respect to all matters arising from or related to the implementation of this Order.
